1. In continuation to this office Notice issued under endorsement No. DLDC-01 of 2017 Dated:22 / 07/2017, the selection committee shall conduct viva-voce of shortlisted candidates for the two (2) posts of class- IV (District Cadre Rajouri) advertised vide notice No. DLDC-01 of 2017 Dated: 22 / 07/2017 shall be conducted on 24 -11-2017 (Friday) at 11:30am. The schedule of viva-voce for shortlisted candidates is annexed at **Annexure "A"** of this Notice alongwith date, time and venue.
2. Shortlisted candidates are advised to report at **10:30 am** sharp for verification of documents.
3. The interview schedule and particulars of the eligible candidates will also be available on official website [www.rajouri.nic.in](http://www.rajouri.nic.in) as well as on office notice board.
4. All/any addition qualifications / reserved category certificate acquired by the candidate after the last date of receipt of application forms shall not be entertained.
5. Mere figuring of name in the list does not entitle the candidate to appear in the interview as it shall be subject to the scrutiny of all testimonials of the candidates shortlisted.
6. No separate interview call letter shall be issued to any candidate whose name figures in the said list and this notice shall be deemed to be interview call to appear before in the interview committee on the schedule date, time and venue. A candidate who fails to appear in the interview on the given date shall not be allowed later and shall forfeit his/her right of consideration.
7. In case of any deficiency with reference to eligibility etc. proved at the time of interview, the candidate shall not be allowed to appear in the interview, or if any deficiency is found subsequently the candidate shall not be considered for selection and will be treated as disqualified.
8. The candidate shall have to produce all original certificates/testimonials as asked for vide above referred advertisement notification before the interview committee at the time of interview. The candidate who fails to produce such certificates/ testimonials may forfeit his/her candidature.
9. Any candidate found guilty of impersonating or submitting fabricated / tempered documents / testimonials or making false statement, incorrect statement or suppressing material information shall be rendered liable to criminal prosecution under law and may be debarred permanently or for a specific period for consideration for any or all recruitments made by the committee. Also canvassing / lobbying in any form will entail disqualification of the candidate.
10. No TA/DA shall be paid for participation in the interview.

**Note:**

1. The shortlisted candidates are advised to bring Photostat copies of certificates/duly attested by Gazetted Officer with his/her seal and self attested by the candidate for depositing with the recruitment Committee on the scheduled date, time and venue of interview.
2. The candidates have been included in the interview list provisionally and only such candidates shall be allowed to appear in the interview who are within age, possess valid category certificates and prescribed qualification before the cutoff date.
3. Mobile Phone is not allowed inside the venue of interview.


