
2. The Tender are to be submitted on a **two Bid format** i.e. **Technical Bid** and **Financial Bid**, formats for which have been provided in the **Tender Document**. The bids must strictly be as per the formats. Tender Documents can be obtained from the office of the Programme Officer ICDS Rajouri against non-refundable cash payment of Rs. 2500/-(Rupees two thousand five hundred only), for general and Rs. 100(One hundred only) for SSI Units (Regd.) upto 4.00 PM on 07-12-2012 or can be downloaded from the website i.e. **www.rajouri.nic.in**. In case Tender Document is downloaded from website, the cost of tender document shall have to be paid in the form of demand draft of Rs. 2500 (in case of general) or Rs. 100 (in case of SSI) which should be accompanied with the technical bid.
